- 3- That the following persons shall be Trustees of the said Trust :
- a- Sh. Joginder Singh Bajwa S/o Sh. Baldev Singh resident of Jiwan Nagar, Tehsil Rania, Distt. Sirsa
 - b- Sh. Savinder Singh S/o Sh. Ranjit Singh resident of Harnia Khurd, Tehsil Rania, Distt. Sirsa
 - c- Sh. Harbhej Singh S/o Sh. Surjan Singh resident of Jiwan Nagar, Tehsil Rania, Distt. Sirsa
 - d- Sh. Ajmer Singh Sandhu S/o Sh. Daljeet Singh resident of Anritsar Kalan, Tehsil Rania, Distt. Sirsa
 - e- Sh. Jaspinder Singh S/o Sh. Dalip Singh resident of Rania Tehsil Rania, Distt. Sirsa
- 4- That the Trustees shall hold property vested in them by virtue of this Trust Deed and other property that may be acquired by them here in after on Trust for the application of the Corpus as well as income thereof for the advancement, furtherence and fulfilment of the following aims and objects :-
- a- To start any other institution or institutions for education or medical aid for the benefit of all persons without distinction of caste, creed or colour prefereably in rural area in the state of Haryana.
 - b- To take on lease or acquire, purchase or construct property and both movable and innoveable for the above objects referred to in Clause 4(a)
 - c- To give donations to the institutions doing similar or allied work.

- d- to disseminate, publish and distribute literature for providing information for prevention and cure of diseases and for child and female welfare.
- e- To grant lump sum or periodical assistance to poor students for their education or to poor widows for their maintenance or to poor persons for medical relief without distinction of caste, creed or colour.
- f- To do all other works for the advancement of the above purposes and to do all other Charitable activities which are duly covered under the definition of Charitable under Income Tax Act, 1961.
- 5- That the Trustees shall receive donations from the public or private institution and private persons for the purpose of advancement of the above object.
- 6- That Trustees shall have power to invest the funds of the Trust in such securities, institutions or Banks as may be approved from time to time under the provisions of the Income Tax Act or other Acts.
- 7- That the first executive committee shall consist of the following persons :

The tenure of Executive Committee of the trust is permanent unless otherwise determined by the Trustees.

- 8- That the Trustees shall be entitled to raise loan from Banks, Financial institutions and any other Private Parties on such rate of interest and other terms as may be applicable and agreed between both the parties. They shall also be entitled to raise such loan by way of mortgage, pledge or otherwise by alienating the property of the Trust. It is further cleared that the raising the loan by way of security against the property of the Trust shall be only for the purpose of developing the objects of the Trust incorporated hereunder supra.
- 9- That the President and any other Trustees so empowered shall have the right to sue or to be sued on behalf of the Trust and shall also be entitled to prosecute and defend any legal action or cases in accordance with resolution or wishes of the Trustees to apply to taxation authorities for any refund due to Trust and received the same. He shall be entitled to make any application to any Court, Office Taxation Authority in respect of matters relating to this Trust.
- 10- That the trustees shall have absolute discretion in determining the nature, Character and structure of buildings necessary for carrying out the objects of the Trust the manner and time of such construction and the furnishing, equipments, fittings. Etc.
- 11- That the Trustees shall have full powers to enter into contracts for carrying out the objects of the Trust and to employ and terminate professional persons, Clerk, Servants etc. on such salary and terms deemed fit and proper by them and to do all other acts and things incidental, consequential or necessary in that connection.

- 12- That the Trustees shall not be liable for any loss not attributable to their own dishonesty or to the willful negligence of any act, known to them to be breach of the Trust & in particulars any one Trustees shall not be entitled to take proceeding against another Trustee.
- 13- That the meeting of the Trustees shall be hold atleast once in a year. The Trust shall hold such other meetings from time to time as may be necessary for furtherance of its objects.
- 14- That the Trustees shall be entitled to frame rules for the Management and Administration of the Trust, for convening meeting of the Trust and for conduct of business therein. They may delegate any of the powers and duties to any one or more of the Trustees or Sub-Committee of the Trustees by a resolution passed in this respect for the purposes of doing such specific work or works or for attending day to day business of the Trust and its institutions.
- 15- That the business in the meeting of Trustees shall be decided by majority and such decision of the majority shall be subject to approval of the President of the Trust. If the President so desire he can over rule any decision of the Trustees and decision taken by him shall be final and binding.
- 16- That a Minute Book shall be provided and kept by the Trustees. This shall contain the proceedings of the meeting of the Trustees and shall be signed by the Chairman of the meeting at the conclusion or at the subsequent meeting when they are fully confirmed.
- 17- That the Trustees shall maintain true any complete account of all monies received spent by the Trustees, or of matters in respect of which such receipts and expenditure taken place and

of properties, credits, and liabilities of the Trust. The account shall be made up at the end of every year ending 31 st March (Financial Year) upon any other period the Trustees may determine from time to time. Such accounts and Balance Sheet shall be examined and passed by the Trustees and their first meeting in the year following or at such other meeting as may be called for that purpose. Such accounts shall be got audited by a person duly qualified to conduct audit under the provisions of Companies Act.

- 18- That such other properties or amount as may be donated by the founders of the Trust or by any other persons or institutions shall also form part of the Trust property and shall be held by the trustees in Trust for furtherance of the objects of the Trust.
- 19- That the Board of Trustees shall have the power to appoint Managing Committee and its Members. Such Managing Committee may be formed for Managing different activities. Such Managing Committee may have its own office bearers. That Board of Trustees shall appoint members of Trust and other outsider also. The Board of Trustees may remove any member of the Managing Committee from time to time by the majority decision.
- 20- That in the event of death, resignation or removal of any Trustees or his refusal to vacate, the vacancy shall be filled by the Board of Trustees preferably unanimously but in the case of want of unanimous, by majority of total numbers of trustees constituting the Board of trustees at that time.
- 21- That non filing of any vacancy, that may be caused will not invalidate the proceedings of the Trust as any thing or act done by the Trustees. Similarly the appointment of Managing Committee shall not divest the Board of Trustees for their powers to act and administer the Trust.

- 22- That the maximum member of Trustees shall be limited to eleven and power of appointing new Trustees shall be vested in the Board of existing Trustees. New Trustees can be appointed by a resolution passed on majority bases in a meeting held of existing Trustees.
- 23- That the Trustees shall have power to invite non Trustees to the meeting of the Trust for advice, information or direction as deemed fit and proper by them from time to time.
- 24- That the Trustees including its Office bearers shall be entitled to charge amount as a salary, fee or honorarium as approved in the meeting of Board of Trustees for the personal services rendered by them.
- 25- That no expenditure of the Trust shall be entitled for want of prior sanction and the said sanction may be granted even after the expenditure is made by Trustees.
- 26- That the Trustees shall be competent to open account in any Schedule Bank in the name of the Trust and President of Trust and/or any other person as authorised in the meeting of trust shall be entitled to operate over the account.
- 27- That the provisions of the Indian Trust Act shall apply to this Trust to the extent these are not in consistent with the above provisions.

IN WITNESS WHEREOF We, the above executant do hereby execute with our free will and in possession of our complete sense, without any co-erection or duress this Deed of Trust and put our signature on the same before the presence who have attested it in our presence at our institute.
